ACCEPTABLE USE FOR INFORMATION AND COMMUNICATIONS TECHNOLOGIES AGREEMENT

Information and communications technologies and the internet are increasingly important resources for students' learning. They provide access to a vast amount of information and opportunities to interact and work with students, schools and people in different geographic areas.

The content of many of the available resources on the internet is beyond the school's control.

It is important that students and parents/caregivers are aware that some of the material available via the internet is inappropriate and of the responsibilities students have when using the Information and Communications Technologies facilities and resources at the school.

As responsible members of the Pasadena Intermediate School community, all students are expected to follow the agreed guidelines.

All Students Using the Information and Communications Technologies Facilities and Resources at Pasadena Intermediate School Will:

1. Follow the guidelines detailed in The Pasadena Code, when using Information and Communications Technologies facilities, including the OLE and PASA SPACE, and resources at the school and the internet.
2. Use the Information and Communications Technologies facilities and resources at the school and the internet for specific educational purposes that are part of class or school programmes.
3. Exercise good judgment when visiting internet sites. Internet sites visited will be relevant to the topic of study and research. Some sites contain inappropriate material, students will not visit these sites intentionally. If students visit a site and find it contains inappropriate material they will leave it immediately.
4. Always check sources, as information that can be found on the internet is not guaranteed to be accurate or true.
5. Never access, have in their possession, or use restricted files, including copyrighted, obscene, pornographic, offensive, violent, dangerous, illegal and discriminatory files. Music files are usually copyrighted, wrestling sites are classified as violent, some material from television programmes is offensive.
6. Computer games, including those that can be accessed on the internet, must not be run or stored on the School Network.
7. Be polite and use appropriate language in on-line communications. Be careful not to make statements or inferences that may offend people of other cultures and beliefs. Do not send or display offensive messages, pictures, or material of any kind.
8. Ensure personal privacy by not supplying names, addresses or telephone numbers.
9. Respect the privacy and property of others and never change any application or file belonging to another person. Do not store or post pictures or video of, or information about other people on the internet or School Network without that person's specific consent.
10. As the owner of a Network Logon Password, accept responsibility for its use. Never loan their Network Logon Password, allow another person to use their Account or use another person's Password or Account.
11. Respect all security provisions on the School Network and Information and Communications Technologies facilities and resources, and never attempt to gain access to any part of the Network they do not have the right to.
12. Use their time on computers, Information and Communications Technologies facilities and resources and the internet wisely.
13. Always report any misuse of the school's Information and Communications Technologies facilities or resources.

14. Be directly responsible for their own OLE (On Line Learning Environment), all content stored and all material published.
15. Never publish or make hyper links to any material that is restricted as described in (5) above, or contains information and other subjects that could be detrimental to Pasadena Intermediate, the Board, staff members or students.

THE PASADENA CODE

Pasadena Intermediate School is a friendly, helpful and caring school. The school programme design and emphasis are on appropriate learning for all students. A school can only operate efficiently and happily at this level with the co-operation of all students.

The Pasadena Intermediate School Code has been developed to promote this co-operation and to provide you with clear expectations of acceptable standards of behaviour.

1. All students are expected to display self discipline, common sense and a respect for the rights of others.
2. All students are expected to attend regularly and be on time for all school activities.
3. All students are expected to participate in school sports, arts, social and cultural activities.
4. All students are expected to give of their best in all school activities.
5. All students are expected to be courteous and sensible at all times. They are expected to allow others to learn without interruption.
6. All students are expected to be sensitive to the feelings of others and to display tolerance of difference including gender, race, culture, religion and ability.
7. Assault, violence, physical abuse, verbal abuse, bullying, social, sexual, religious, physical, intellectual, cultural, age, gender harassment and foul language are considered anti-social and unacceptable forms of behaviour.
8. All students are expected to be honest. Property and possessions belonging to others will be left alone.
9. All students are expected to contribute to keeping the school clean, safe and an attractive environment and to treat school property with care and respect. Vandalism and graffiti are considered anti-social and unacceptable forms of behaviour, and for negligent or deliberately damaged school property students/parents/caregivers can expect to be asked to make an appropriate reimbursement.
10. When a student leaves the school, all property belonging to the school is to be returned and any outstanding accounts are paid in full.
11. All students are expected to wear full and correct school uniform at all times.
12. Cigarettes, matches and other dangerous goods, substances and instruments are not permitted at Pasadena Intermediate School.

Show courtesy and consideration to others at all times;

Follow the rules and instructions of staff, volunteer helpers and other supervisors at the event;

Take part in all activities within challenge-by-choice options;

Look after myself and my personal belongings;

Declare medical conditions that could affect my participation in the event;

Accept the rules set by the school and the venue for the event, even if they are different from what is accepted at home.

My actions are considered unacceptable by staff;
